

## Prairie Farms Dairy “Drink Local” Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. Eligibility: Prairie Farms “Drink Local” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the Prairie Farms region, in the following states of Illinois, Iowa, Indiana, Kentucky, Michigan, Minnesota, Mississippi, Missouri, North Dakota, Ohio, South Dakota, Tennessee and Wisconsin, who are at least eighteen (18) years old as of the last day of the month prior to entry. Employees of Prairie Farms Dairy, Inc., as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decision, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor: Prairie Farms Dairy, Inc., 3744 Staunton Road, Edwardsville, IL 62025

3. Timing: The Sweepstakes begins on March 21, 2022 at 12:00 p.m. Central Standard Time (“CST”) and may end at any time (the “Promotion Period”). Random drawings from all eligible Sweepstakes entries will take place throughout the Promotion Period.

4. How to Enter: During the Promotion Period visit: <https://www.Prairiefarms.com/drinklocal> and follow the instructions to complete and submit the registration. You automatically will receive one (1) entry into the Sweepstakes. Duplicate entries per day and automated entries will be removed from consideration. Limit one (1) prize per household during the promotion period. All entries will be reviewed by the Sponsor and may, at the Sponsor’s sole discretion, be posted on prairiefarms.com and then shared through Prairie Farms’ accounts on various social media services, including but not limited to Facebook, Twitter, Instagram and Pinterest.

Limit: Each participant may enter one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawings: Sponsor will randomly select the twenty five (25) potential Prize Package Sweepstakes weekly winners from all eligible entries received during the Promotion Period. Each potential winner will be notified by mail or email. If a potential winner of a prize cannot be contacted, or fails to provide any requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits the prize.

Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Prize packages will be fulfilled approximately 6 weeks after the conclusion of the Promotion Period, and/or notifications of award recipients. Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners is final and binding in all matters related to the Sweepstakes.

Prairie Farms and/or North Star products may not be available in all areas; no substitutions are permitted.** Winner is responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received for each prize during each Entry Period. Total ARV Sweepstakes Prize Package: \$25. Limit: One (1) prize per person.

7. Release: By receipt of the prize, winner agrees to release, discharge and hold harmless Prairie Farms, North Star and all subsidiaries from any actions, claims, damages or liabilities including damages to property or personal injury or death arising from participation in the sweepstakes and in the acceptance and use or misuse of the prize.

Publicity: Except where prohibited, participation in the Sweepstakes constitutes each winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.

9. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. 10. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind,

including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.
