

Prairie Farms Dairy “July Ice Cream Month” Sweepstakes Official Rules  
NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Prairie Farms “July Ice Cream Month” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the Prairie Farms region, in the following states of Eastern Arkansas, Illinois, Indiana, Kentucky, Michigan, Minnesota, Central/Eastern Missouri, South Dakota, Tennessee and Wisconsin, who are at least eighteen (18) years old as of the last day of the month prior to entry. Employees of Prairie Farms Dairy, Inc., as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decision, which are final and binding in all matters related to the Promotion. 3. Timing: The Sweepstakes begins on July 3, 2023 at 12:00 p.m. Central Standard Time (“CST”) and ends July 31, 2023 at 11:59 p.m. (the “Promotion Period”). Random drawings from all eligible Sweepstakes entries will take place throughout the Promotion Period.

4. How to Enter: During the Promotion Period visit:

<https://www.Prairiefarms.com/icecreammonth> and follow the instructions to complete and submit the registration. You will automatically receive one (1) entry into the Sweepstakes.

Duplicate entries per day and automated entries will be removed from consideration. Limit one (1) prize per household during the promotion period. All entries will be reviewed by the Sponsor and may, at the Sponsor’s sole discretion, be posted on prairiefarms.com and then shared through Prairie Farms’ accounts on various social media services, including but not limited to Facebook, Twitter, Instagram and Pinterest.

Limit: Each participant may enter one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawings: Sponsor will randomly select one (1) grand prize winner and twenty five (25) potential Prize Package Sweepstakes weekly winners from all eligible entries received during the Promotion Period. Each potential winner will be notified by mail or email. If a potential winner

of a prize cannot be contacted, or fails to provide any requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits the prize. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or

to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
